Technical Information



This decorative, quick-drying lacquer gives the painted objects strikingly real-looking silver leaf optics. Resistant to abrasion, suitable for indoors and outdoors. For use on metal, glass, ceramics, stone, wood, paper, carton etc. Possible applications: picture/mirror frames, furniture, borders/ornamental battens, signs, decorations, etc.

How to use

- Remove residues of old paintings and rust, then prime if necessary.
- The surface has to be clean, dry and free from fat.
- Cover areas not to be painted.
- If necessary, apply the white DUPLI-COLOR Effect Primer.
- Before use, shake the can for 3 minutes.
- Test spray at an invisible spot to check colour-matching and compatibility of the lacquer.
- Spray from a distance of approx. 25 cm several thin coats.
- Do not spray over synthetic paints!
