## Technical Information

### How to use

- The ground has to be clean, dry and fat-free
- Remove loose flakes of old paints and de-rust, then sand and prime.
- Before painting plastic parts, use DUPLI-COLOR Plastic Primer. Let dry for 1 - 2 hours.
- Mask off surfaces not to be painted.
- Before use, shake can for 3 minutes.
- Test colour of spray and compatibility at an invisible spot.
- Spray distance: approx. 25 cm
- Spray several thin coats in approx. 2 minute intervals.
- Re-coatable within 2 hours or not earlier than after 24 hours.
- Do not coat with acrylic lacquer - not even after curing!

#### Disposal
